FLUOROCARBONS EMISSION REDUCTION ACT DESIGNATED PRODUCT SYSTEM TARGET VALUES AND TARGET YEARS

EXTENDED ABSTRACT

The fluorocarbon refrigerants (CFCs, HCFCs, HFCs) used in commercial refrigeration and air conditioning products (Type 1 specified products) cause ozone layer depletion and global warming. Therefore, the Act on Rational Use and Proper Management of Fluorocarbons (Fluorocarbons Emission Control Act), revised and enforced on April 1, 2015, requires the recovery of fluorocarbon refrigerants from commercial refrigeration and air conditioning products. Products that are technically capable of reducing fluorocarbon emissions during use, etc., are designated as "designated products," and efforts have been made to reduce the GWP of the fluorocarbons used in these designated products.

This article introduces the targets and the current status of commercialization for designated refrigeration and air conditioning products.
